The Oregon Ocean Policy Advisory Council (OPAC) in partnership with the Office of the Governor, is seeking qualified applicants to serve on the Council representing coastal conservation and environmental interests.

Ideal candidates for the Coastal Conservation and Environmental Organization position will be an Oregon resident who has a broad-reaching understanding of conservation interests, with a specialization in marine and coastal subjects. Desirable attributes include familiarity with marine and coastal planning and policy, understanding of conservation initiatives on the Oregon Coast, association with one or multiple conservation groups with coastal and marine focus, familiarity with OPAC and/or OPAC working groups, and previous experience representing broad interest groups as a member of a board, commission, or sub-committee.

The Oregon Ocean Policy Advisory Council (OPAC) is a legislatively mandated marine policy advisory body to provide, among other statutory charges, advice to the Governor, state agencies and local governments on ocean policy and resource management matters (ORS 196.433). OPAC membership is diverse and made up of representatives from coastal community interests, state agencies, conservation interests and the general public. OPAC members meet bi-annually with all members volunteering their time and commitment. Travel support to attend meetings and workshop is available.

Interested individuals must submit a cover letter outlining their interest and qualifications, as well as a resume, and completed Executive Appointment Interest form by **December 14**, **2017** to be considered by the Office of the Governor and ultimately confirmed by the Oregon Senate.
