I am interested in remaining in the Conservation Representative position on the Ocean Acidification and Hypoxia Council.

I am a long term Oregon coastal resident, with a degree in marine resource management and long involvement in coastal conservation issues, at both the policy and on-the-ground level. I work actively with the fisheries management council and with watersheds councils and have experience in local and state land use and land management issues. These backgrounds allow me to understand the larger context in which OAH issues reside and to help promote awareness and progress on the issue. I also am actively engaged with groups and on the ground promoting tidal marsh and submerged aquatic vegetation (eelgrass and kelp) conservation. These habitats offer potential for reducing other stressors on our fish and providing some localized buffering and can help build broad support and action.

Ocean acidification and hypoxia events are conditions that are already "here" and are and will continue to be intensifying. The recent information on impacts to crab larvae may have been a wake-up call for many, but generally awareness needs to be broadened to get support for the priority actions called for in the OAH Council's first 5-year action plan. To make progress on the focus and priorities called out in this plan, we need to build understanding of the impacts and how we might be better able to understand, minimize, and mitigate them so that support for the funding, expertise, agency actions and other commitments can be achieved. I would like to continue to be involved to help the OAH Council achieve these goals. In addition to serving on committees such as the education and outreach committee, I will continue working to build awareness and support in the conservation community for progress.

I hope you will consider me for re-appointment for this position.

- Founded the MidCoast Watersheds Council and help it to assess, conserve and restore habitat within a nearly 1 million acre watershed on Oregon's central coast key to sensitive coho and steelhead and important for chinook. Continued support to the group's administrative and technical processes over its 20 years of operation has

helped it become one of the most recognized in state. Each year it accomplishes over \$500,000 million dollars of habitat restoration projects targeted to meet specific limiting factors and assessment needs.

- Secured grant funds for and managed an estuarine protection and restoration prioritization project for two key estuaries in Oregon; and helped gather information and secure federal and state support and funding for 600 acres of salt marsh and forested buffer conservation and 300 acres of fresh water marsh and forest buffers for highest priority areas on the central Oregon coast.
- Managed the 'Flying for Fish Habitat Program' in Washington state that partnered with the non-profit group 'LightHawk' to take mayors, city councilors, water purveyors, fishermen, agency personnel, foundation staff, and others on interpreted over-flights of their watersheds. Project resulted in increased awareness and support by city officials for watershed protection ordinances, growth management policies, and steep slope protections and has gained funding for specific restoration and acquisition projects. Similarly, ground-based tours of watershed restoration projects for decision makers and the media were conducted in California and Oregon.
- Helped research, write, and support the PFMC Groundfish Essential Fish Habitat Draft Environmental Impact Statement work and oversee the providing of public access to this newly gathered information through a web-based interface
- Service on the Pacific Fishery Management Council's habitat committee has advanced the group's advancement of ecosystem based fishery management, krill protection, and strengthened input on Klamath and Columbia River salmon issues, and salmon essential fish habitat. Has served as co-chair or vice-chair for over 6 years.
- Help found and continue to serve on the Pacific Marine Estuarine Fish Habitat Partnership, a group dedicated to work on estuarine and nearshore habitat conservation and restoration in Washington, Oregon and California, particularly focusing on juvenile fish habitat issues.

Re: OPAC membership application.

On reflection of my personal interests and options open to me I have come to the conclusion that my membership application for the at large position on OPAC was premature. I had originally made the application because of concerns regarding the impacts of global warming on the marine ecosystem. As I had indicated in my initial cover letter a primary interest related to impacts of acidity, hypoxic zones and temperature change on this ecosystem. In retrospect, I feel that the Ocean Acidification and hHypoxia Council would be a better fit for me, if I were accepted as a member of that Council. I had contemplated applications to the open positions on both councils but that presented a potential appearance of impropriety, seeking the public at large open seat on one Council and the environmental open seat on the other. Accordingly I would like to withdraw my application for the seat on OPAC, but I would like to make application for the environmental position on OAH.

Like many reasonable people, I have significant concerns about the evolving impacts of global warming and have chosen to attempt to become involved, if my application is accepted, because of a desire to be a participant rather than a spectator in strategic planning. I realize that I would be joining a well established group that has already developed a strategic plan for council activities. I do have an overview as to what I would like to see addressed by the Council, realizing that these issues may likely have been addressed in whole or in part during prior meetings. I see the Council role as focusing on two parallel areas. One relates to the issues reflected in the video that was posted on the website, using best science to maintain and enhance productivity of commercially utilized species in the setting of progressively worsening water qualities. The other relates to reviewing the composite knowledge of the various unique ecosystems in our offshore waters and assessing what factors might be managed to enhance survivability in a much broader context than just related to commercial species. Indeed, I can envision a worst-case scenario in which none of the commercially exploited species will survive. Accompanying global warming will be food crises and large-scale migratory problems. In the face of declining food supplies I doubt that harvest quotas will remain politically viable and I suspect these species will be harvested to non-viable survival population levels. Obviously we need to sustain these species for as long as we can.

I'll use by example the well-known crisis of coral reefs in warmer climates, and the factors involved in coral bleaching. As undoubtedly everybody realizes, research focus at this time relates to temperature related disruptions of the symbiotic relationship between coral and algae. This presently is considered to be more related to temperature elevation than increased acidity, with the coral ejecting the algae, perhaps due to toxin production by the algae. Attempts are being made to selectively breed more temperature tolerant algae in the hopes of reestablishment of the normal symbiotic relationship. Generically, these types of approaches may have applications within our system for different species critical to a healthy ecosystem. I view the role of the Council as reviewing available information regarding our ecosystems, and using close coordination with scientists at OIMB and the Hatfield Marine Science Center, to devise appropriate research proposals to fill in gaps of knowledge. It is unclear to me as to whether the Council would also be able to play some role in facilitating funding through grant applications for these research projects.

It may or may not be useful to also consider information regarding scientific analysis of prior periods of global warming and/or ocean acidification. This information may well be sketchy but they give some insights to help in focusing on which components of the ecosystem have the potential for survival with active management. Some of this information may be downright depressing; I recently read that during a

period of oceanic change associated with volcanic eruption during the Cretaceous period only the algae survived and it took a long time for that to recover to meaningful levels. Nonetheless, we need whatever information available to facilitate decisions regarding wise management.

I apologize for complicating this application process by the change in strategy. I had previously attempted to access the component of your website with the application form for OAHF and for some reason that section was inaccessible. Obviously a lot of the information in terms of background, resume, etc., has already been submitted. If additional information is needed or additional forms need to be filled out please let me know. My timeline is that I will be leaving the country on Thursday, not returning until well after the deadline for the OAHF application submission. Accordingly I would need to have access to and fill out any additional paperwork the early part of this week. Thank you for your consideration.
