

# **Oregon Ocean Policy Advisory Council**

**Meeting Summary – November 4, 2021**

**Virtual Meeting**

## **Issues Decided/Positions Taken**

- The Draft Meeting Summary of the May 17, 2021 Ocean Policy Advisory Council (OPAC) was approved by consensus, without edits.
- OPAC approved, by consensus, new Executive Committee members including:
  - Chair Susan Chambers
  - Vice-chair Tara Brock
  - At-Large Member Jamie Fereday
- OPAC approved, by consensus, the following motions regarding Territorial Sea Plan Part Three amendments:
  - The Ocean Policy Advisory Council moves to adopt the TSP Part Three draft amendments, as provided by DLCD staff on 11.3.2021 and will transmit them to LCDC for their consideration along with the recommended sites for implementation as specified in the May 17 Meeting Summary. In doing so the Council has reviewed the required rulemaking documents (public notice and fiscal impact statement, and housing impact statement).
  - The Ocean Policy Advisory Council moves to support a further evaluation process for the consideration of site proposals in the “continuing consultation category” as recommended by DLCD staff in the letter from September 16, 2021.
    - OPAC agreed that a further evaluation process would not be included in future iterations of the site-based designation proposal process.

## **Presentations**

- DLCD Staff, *Andy Lanier*, briefed OPAC on the recommended amendments to the TSP Part Three Rocky Habitat Management Strategy, Section E and Appendix C changes and the recommended revisions to the strategy resulting from tribal consultation.
- Three presentations made up the offshore wind energy planning related panel including:
  - Oregon Department of Energy Senior Energy Policy Analyst, *Jason Sierman*, provided a briefing on work plans associated with Oregon House Bill 3375.
  - Bureau of Ocean Energy Management Staff, *Necy Sumait* and *Whitney Hauer*, provided an update on the status of offshore wind planning and the activities of the BOEM Oregon Intergovernmental Task Force.
  - DLCD Federal Relations Coordinator, *Deanna Caraciollo*, provided a briefing on the state federal consistency review process for OSW development.
- DLCD Staff, *Andy Lanier*, briefed OPAC on the legislative directives to OPAC in House Bill 2603 that relate to TSP Part Four and the siting and permitting of undersea cables, and the establishment of a TSP Working Group for Part Four.
