SUMMARY

This meeting was led by Marcus Chatfield, Undersea Cable Coordinator (DLCD). The goal of this meeting was to discuss the Working Group’s Legislative Directive, receive an update on the Undersea Cable Landing Siting Report, participate in a question and answer session with Ryan Wopschall on the Best Practices in the Undersea Cable industry Report. Meetings of the Working Group will provide guidance and recommendations to be used by DLCD staff to generate language amendments for the TSP Part Four. Final recommendations will be presented to the Ocean Policy Advisory Council (OPAC) for their consideration after the Working Group concludes their meetings later in the Spring, thereby meeting the timeline established in HB 2603.

The meeting opened at 9:00AM with introductions of meeting participants, a discussion of continued recruitment, the meeting schedule was discussed.

The landing site tour and hybrid meeting were discussed. The decision was made to send out a survey to the Working Group members to finalize plans for the site tour date.

Andy Lanier led a discussion about the Legislative Directive to the Working Group.

During the discussion of the Legislative Directive, a Landing Site Criteria Subcommittee was formed to develop policy which lists favorable and unfavorable criteria for undersea cable landing sites in Oregon.

Reed Burgette presented an update on the Undersea Cable Landing Siting Report focused on site suitability.

Meeting broke for Lunch at 11:30 AM.

Public Comment period opened at 12:30 PM. There were no public comments.

Ryan Wopschall led a Question and Answer session related to the Best Practices in the Undersea Cable Industry Report.

The group then walked through the first draft of amendments to the TSP Part Four. There were questions about the authority the TSP has to direct federal agencies. The final draft of the TSP Part Four amendments should be reviewed by Jeff Burrig for Federal Consistency. Points were made to make the document more clear. More comments were requested to be sent in written form via email.

A plan for the next meeting was developed. Meeting materials to be provided to the Working Group before the February 1st, 2023 meeting were discussed. Sending out word documents or shared documents of the draft amendments was suggested.
